## Interventions with Addiction Disorders PLA

Advanced, Liberal, 4 credits

Interventions with Addiction Disorders is considered to be an advanced level knowledge that is liberal. It represents higher level theory and concepts that human service workers have acquired through applied practice. Advanced level knowledge indicates that you are able to use terminology, concepts, and theory in an applied way. Interventions with Addiction Disorders is more often about why we do things (i.e., liberal) and not necessarily how we do things (i.e., non-liberal). At Empire State College, Interventions with Addiction Disorders is considered to be an advanced and liberal course.

If you utilize an outside source, such as a website or a book, make sure to reference this in your response.
